**RENTAL CONDITIONS AND TERMS**

Please read, sign and date the following RENTAL agreement/disclaimer. Email to info@jammatn.com or fax to 877.585.5187. This agreement must accompany payment and or be received before we leave our facility for your event. Rental Rates includes transportation to and from your event location (up to 250 miles, one way). Additional mileage rate (fuel surcharge) will apply at 1.00 per mile, one way. We provide a two-person installation and disassembly assistance team along with your workers. You are required to provide a minimum of two able-bodied laborers to move and set-up cage components from the trailer to the set-up location.

The basic rental charge per event day is \$1250.00, plus reasonable hotel overnight charges.

Set-up access must be provided a minimum of 5 hours prior to start of event. Normal setup conditions include morning set-ups for evening events. Evening or Day Before set-up requirements are sometimes available per client and event needs, with additional time set-up fee applicable. Disassembly must take place within 2 hours after event is complete. Additional disassembly hours are billed at \$85.00 per hour over the allotted time. If the trailer cannot be backed to within 20 feet of the actual set-up point, or there is a RUSH on your part for set-up, an additional 2-4 laborer's will be required for the set-up and tear-down process. If renter CANNOT provide the additional laborers a \$200.00-\$500.00 charge will apply, depending on distance to drop point. Elevators, long hallways, stairs, etc. will result in additional fees. (Please measure and know your event location) If the Renter is scheduling more than 30 days prior to event, a 50% deposit of the total rental fee amount plus 50% of the fuel surcharge is required to secure rental date. The remaining 50% balance of the rental fee and fuel surcharges is due NO LATER THAN 72 hours before we leave our facility.

If the Renter is scheduling less than 30 days prior to event, the full rental fee plus the full fuel surcharge is required at time of scheduling to secure rental date. If you postpone your event, there are no penalties, as long as you reschedule, at our convenience per our schedule, at the time you post-pone. If you cancel the rental or your event gets cancelled for any reason whatsoever and you cannot re-schedule, and we cannot rent the cage to another party for that date, you forfeit all monies paid.
